General Programs/Other: In fiscal year 2021, the AICGS Society, Culture & Politics Program commemorated the 30th anniversary of German Unity with a series of essays. It also began a year-long project aimed at examining the 2021 German federal elections. The Foreign and Security Policy Program focused on revitalizing transatlantic security cooperation with projects supported by the U.S. Embassy Berlin and the German Ministry of Defense. The AICGS Steven Muller New Initiatives Program supports AICGS podcast, The Zeitgeist, which regularly interviews high-level and expert speakers on a variety of topics, including right-wing extremism and transatlantic trade. Another main focus included producing articles and events leading up to the U.S. election, examining the impact of the election outcome on the transatlantic relationship.

4b (Code:) (Expenses \$ 171,655. including grants of \$) (Revenue \$)

Goeconomics Program: The AICGS Goeconomics Program promotes original thinking and debate on U.S., German, and EU global economic strategy with a focus on ways that trade, investment, financial, and technology policies can advance their shared interests, prosperity, and values. Key topics in fiscal year 2021 included trade and investment; the global economic order; digital policy; domestic economics; and relations with China. The program publishes a blog, The Wider Atlantic, in addition to regularly soliciting expert analyses, appearing in news media, and hosting high-profile events. Such events in 2021 covered topics including the impact of the U.S. presidential election on German and European economies, including in the areas of digital and climate policy; building a positive transatlantic agenda; and important perspectives on the economic effect of COVID-19, including supply chains.

Thyssen China Project: The program Building Transatlantic Cooperation on China: Key Issues for the United States and Germany in 2020-21 Transitions convened high-level American-German workshops on the most pressing challenges for Washington and Berlin's foreign and security policy toward China. The issues included Digital Infrastructure Policy and Foreign Investment Screening. AICGS invited top American and German officials from key government agencies, legislators, academics, and other experts to digital workshops. Participants were briefed on the latest policy and legislative developments in the U.S. and Germany and offered policy recommendations for American-German cooperation based on the governments respective policy tools as well as possible scenarios. The project included policy papers for discussion and a final Policy Report.
